ERB Course General Admission Criteria

Eligible Employees of Hong Kong who aged 15 or above. (Please refer to application guidelines for details)
Applicants of Placement-tied Course must be unemployed or non-engaged, and intend to engage in employment in jobs trained for.

Course Fees of Non-Placement-tied Courses:

Trainees who have nil income and monthly income of \$15,000 or below, can apply for Course Fee Waiver;
Trainees who have monthly income between \$15,001 and \$23,500, can apply for "Subsidised Fee";
Trainees who have monthly income of \$23,501 or above, can apply for "Course Fee".

*Applicable to eligible trainees of placement-tied courses with attendance rate of at least 80%.
